Starksboro Selectboard Meeting Feb. 19, 2024 Unapproved

Koran Cousino called the meeting to order at 6:33 p.m. at the Starksboro Town Clerk's office.

Amanda Preston gave an overview of the Spring Gravel Ride hosted by the Catamount Outdoor Family Center on May 11th.

Carin McCarthy motioned to approve the Catamount Outdoor Family Center Spring Gravel Ride. Second by David Schmidt. Motion approved unanimously.

Finances with Darlene Kelly from NEMRC:

Darlene Kelly gave an overview of the Balance Sheet and Budget Status Report. Darlene Kelly suggested raising debt payment funds in the highway budget and using capital planning/reserve funds for future expenses. This would increase our budget greatly in the first year we make this change.

Action: Darlene Kelly will create a debt schedule for Ali Thompson.

Action: Amanda Vincent will work with Darlene Kelly to move all the FEMA invoices to the

correct line items.

Action: The Selectboard will review reserves annually & work to develop a capital plan.

Addison Housing Works:

Preliminary engineering reports were done for water, wastewater and stormwater in Brookside, Lazy Brook and Hillside, with about \$20 million in total costs for all three projects. Hillside is the focus and most attainable. HUD Community Development Block Grant Programs are only available to municipalities. There is general support from the Selectboard to apply for this.

Town Hall Project:

Susan Thompson proposed the RFB for the construction of the shaft for the lift to the Selectboard for review. We have received our third extension for this grant, with the anticipated completion being the end of July.

Jerusalem Schoolhouse & Fire Station Project:
