## **Road Update**

- Robert Young Road A grant for ditching portions must be completed before October. The entire road will need ditching and culverts in future.
- Gravel stock A lot of stock has been used to address the storm damage. The town will need to purchase additional gravel in the future.
- Quaker St. needs a culvert Crew was planning to install right before the flood but it was delayed/washed out. Josh will complete his work before Sept. when the Bristol town road work will begin.
- Koran has been listening to the VEM weekly updates and updated the group on key points.
- Ireland Rd. scope of work Town contracted out for ditching, culverts need cleaning again; plan to replace culvert by Lyons with 30" (instead of 18")

# Setting of municipal and local tax rates

**Motion:** Eric Cota made a motion to set \$0.4304 as the municipal portion of tax rate. David Schmidt seconded. **Vote:** Motion approved unanimously.

Motion: John Painter moved to make the .0110 veterans exemption. Eric Cota second.

Vote: Motion approved unanimously.

**Motion:** Eric Cota made a motion to set the homestead late filing penalty at 8%. Carin McCarthy second.

Vote: Motion approved unanimously.

### **Jerusalem Fire Station #2**

Tom Estey has limited time in the near future so Luke McCarthy is taking the lead on this project. Parent Construction has given an estimate for concrete.

#### **Capital maintenance**

- Heat pumps need to be replaced in several buildings: garage #1, food shelf #2, town clerk #3
- Food shelf roof needs quotes tree removal from behind building will help with moisture issues. John will look at the trees and see what needs to be done.

### **FEMA Buyout Discussion**

- Town would need to hold the land in perpetuity if a landowner opts for the buyout process.
- Town must consider the impact for the town, then submit proposals to the state, which will include costs of demo and removal, and restoration.
- If a property is in the buyout, it will come off the grand list (loss of tax revenue).
- Bristol has taken on some properties from buyouts and would be a resource for information.
- The land becomes town land, similar to the town forest. It must remain as open space (no development).
- KC asked about liability and issues if the town had a parcel in between residences that stay
- (Flood resilient communities Middlebury example took 3 yrs)
- Bristol example old tin city, now green space and somewhat maintained (mowing 3x yr)

#### **Mail Review**

1. Email received from Bob Gifford re: roads: Stokes Hill - Class 4 - gully erosion and town is responsible. Clifford Tree farm hired a contractor do work privately and a private donation made to cover the gravel costs of the town. Town tandem hauled the gravel (cost for the town). Similar situations on Class 4 roads have been considered by the Selectboard on an as needed basis.

### Selectboard Roundtable

- 1. Carin is working on a document for emergency planning she'd like templates or comparables from other similar sized towns.
- 2. Carin will not be here for primary. She asked about volunteers and building excitement around the election.
- 3. BCA site liability discussion about if a waiver or statement of waiver is required.
  - a. VLCT is a resource
  - b. What does the town need to consider? What is legally required?
  - c. Carin will follow up with VLCT
- 4. Koran noted there is a tree across Lewis Creek that is near the dry hydrant.
  - a. The board will ask Jeff Parent if it can be pulled down safely.
